Creator, Writer, Supervising Producer: Created, wrote and produced two seasons of "*RAISING THE BAR*" a one-hour episodic television drama. Sole credited writer on seven episodes (including the pilot) shared "Written by" credit on one, "Created by" and "Supervising Producer" credit on each of the other aired episodes. The show's premiere, on September 1st, 2008, garnered 7.7 million viewers, the highest ratings for a season premiere in the history of ad-supported cable television.

Across two seasons and twenty-five episodes, the show investigated the systemic flaws in the criminal justice system, delving into prosecutorial misconduct, and the myriad ways the frictional costs of an overburdened system conspire to make justice elusive for the poor and disenfranchised. Scrupulously accurate, the show exposed a side of the system other shows avoided: low-level offenses disproportionately filed against poor people, with life altering consequences.
